APPLICATION FOR A CASH REFUND OR TRANSFER OF FUNDS
NON-VESTED EMPLOYEE

Having terminated my employment with a CSI member school and consequently also my active participation in the Christian School Pension Plan (the "Plan") prior to completion of the vesting requirement, I request:

A refund of all my contributions, together with accrued interest, to me. By governmental regulations the taxable portion of this refund will have a mandatory withholding of 20% deducted before payment.

A transfer of the taxable portion of my contributions with accrued interest to another qualified employer plan or an IRA and a refund in cash of the nontaxable portion of my contributions.. The Direct Rollover will be to:

I understand that the acceptance of a cash refund cancels all rights to my accrued pension. I further understand that, subject to certain conditions which follow, upon reemployment and reenrollment in the Plan, I have the option to repay to the Trust Fund the full amount of my refund, plus interest from the date of the refund to the date of repayment; provided, however, that I have this option only if I make the repayment on or before five years have elapsed since the date of reemployment and if I have been reemployed before incurring a Break in Service of at least 60 consecutive months. In such event my prior service will count toward vesting and if my combined CSI employment ultimately satisfies the vesting requirement set forth above, I will be entitled to my full accrued pension plus the pension which I accrue after reemployment.
