Survey Results

- Earlier this fall we requested your participation in a survey of board/employee payment of health insurance costs for employees and dependents. The questionnaire was mailed to 254 CSI member organizations. 169 responses were received.
• Following are the results; the numbers in brackets indicate the results of the previous surveys:

Of the member organizations, grouped into three main categories:

Of the 132 Boards which pay part of the cost:

- 9 Boards, or 6.8%, pay 100% for the employee, 75% for dependents.
9 Boards, or 6.8%, pay 100% for the employee, 50% for dependents.
25 Boards, or 18.9%, pay 100% for the employee, 0% for dependents.
9 Boards, or 6.8%, pay 90% for the employee, 90% for dependents.
13 Boards, or 9.9%, pay 80% for the employee, 80% for dependents.
9 Boards, or 6.8%, pay 75% for the employee, 75% for dependents.
6 Boards, or 4.6%, pay 50% for the employee, 50% for dependents.
52 Boards, or 39.4%, pay various other portions.

— In looking towards next year:

Of the 29 currently paying full cost, 25 or 86.2% expect to pay the full cost and 4 or 13.8% are uncertain what percentage will be paid.

Of the 132 currently paying partial cost, 7 or 5.3% expect to pay a different percentage of the cost, 91 or 68.9% expect to pay the same percentage of the cost, and 34 or 25.8% are uncertain what percentage will be paid.

Of the 8 currently paying none of the cost, 4 or 50.0% expect to pay none of the cost, and 4 or 50.0% are uncertain what percentage will be paid.

— Regarding offering a Flexible Spending Account Plan for employees to use to pay benefit related expenses with pre-tax dollars:

118 Boards provide a Flexible Spending Account Plan.

51 Boards do not provide a Flexible Spending Account Plan.

Of those not now offering a Flexible Spending Account Plan, 6 Boards are considering such a program next year.
