Prize Drawing for Complying with Preventive Care and Disease Management

In addition, we will conduct a prize drawing in September 2008 for participants who are covered for health and qualify for a \$75 gift card, get a routine physical, and enroll in a disease management program (if eligible) by June 1, 2008. Prizes will consist of:

Timeline for Participation

To qualify for the rewards, you must:

1. Complete the Health Risk Appraisal (HRA) by November 30, 2007.
2. Have a routine physical between May 1, 2007, and June 1, 2008.
3. Opt into a disease management program before June 1, 2008, if you have diabetes, a cardiovascular disease, or respiratory disease.

How to Login

1. Go to www.CSIonline.org/benefits and select Links. Select the link to Trustmark's Healthy Foundations under U.S. Insurance.
2. Once in the Trustmark web site, click on the Healthy Foundations link.
3. Click on the **Healthy Foundations Login**.
4. New users should select **Register Here**, complete the registration, and click on **Submit Form**. Existing users should enter their User Id and Password and click on **Login**. This will bring you to the Health Center.
5. To take the Health Risk Appraisal, select **Enter** in the section labeled "Health A to Z." You will now be in the Health Dashboard.
6. Select **Take a Health Risk Appraisal** under the section labeled "I Would Like To:"
7. Read the privacy statement and select "I authorize Trustmark to receive..." so that CSI can send you the \$75 gift card when you complete the health risk appraisal.
8. Read the frequently asked questions, and select **Continue to HRA**.
9. Answer the question regarding smoking and select **Enter**.
10. Complete the Health Risk Appraisal and submit it.
