Survey Results

- Earlier this fall we requested your participation in a survey of board/employee payment of health insurance costs for employees and dependents. The questionnaire was mailed to 320 CSI member organizations. 195 responses were received.
- Following are the results; the numbers in brackets indicate the results of the previous surveys:

Of the member organizations, grouped into three main categories:

			<u>2006</u>	<u>2005</u>	<u>2004</u>	<u>2003</u>
24	Boards, or 12.3%,	pay the <u>full</u> cost.	{17.2}	{13.2}	{10.1}	{13.8}
155	Boards, or 79.5%,	pay <u>part</u> of the cost.	{78.1}	{78.6}	{79.8}	{78.7}
16	Boards, or 8.2%,	pay <u>none</u> of the cost.	{ 4.7}	{ 8.2}	{10.1}	{ 7.5}

Of the 155 Boards which pay part of the cost:

8	Boards, or 5.2%,	pay 100% for the employee,	75% for dependents.
9	Boards, or 5.8%,	pay 100% for the employee,	50% for dependents.
27	Boards, or 17.4%,	pay 100% for the employee,	0% for dependents.
13	Boards, or 8.4%,	pay 90% for the employee,	90% for dependents.
16	Boards, or 10.3%,	pay 80% for the employee,	80% for dependents.
10	Boards, or 6.5%,	pay 75% for the employee,	75% for dependents.
5	Boards, or 3.2%,	pay 75% for the employee,	0% for dependents.
67	Boards, or 43.2%,	pay various other portions.	

— In looking towards next year:

Of the 24 currently paying full cost, 20 or 83.3% expect to pay the full cost and 4 or 16.7% are uncertain what percentage will be paid.

Of the 155 currently paying partial cost, 9 or 5.8% expect to pay a different percentage of the cost, 114 or 73.6% expect to pay the same percentage of the cost, and 32 or 20.6% are uncertain what percentage will be paid.

Of the 16 currently paying none of the cost, 5 or 31.5% expect to pay none of the cost, and 11 or 68.5% are uncertain what percentage will be paid.

— Regarding offering a Flexible Spending Account Plan for employees to use to pay benefit related expenses with pre-tax dollars:

126 Boards provide a Flexible Spending Account Plan.

69 Boards do not provide a Flexible Spending Account Plan.

Of those not now offering a Flexible Spending Account Plan, 7 Boards are considering such a program next year.
